Online: Registering online at <https://nafcannual.trucking.org/> is the fastest and easiest way to register for ATA's National Accounting & Finance Council (NAFC) Annual Conference & Exhibition. Email/Fax: Emailed and faxed registrations must include payment information and require 4 business to process. Allow 4 business days processing time before following up on all email/fax requests.

Mail: Mailed registrations require 4 business days to process (once received) and must include payment.

Confirmation Email: Once your registration is successfully processed, you will receive a confirmation containing the hotel booking link. You must be a registered attendee to reserve a hotel room at the ATA discounted rate. As indicated on registration page 1, confirmation emails can only send to one email address. Any additional NAFC registration communication will go to the same email address.
